CASH BAR: CASH BAR PRICING IS DETERMINED BY WHICH PACKAGE YOU CHOOSE. A SPECIAL DESIGNATION LIQUOR LICENSE IS REQUIRED FOR ALL CASH BARS. ACA WILL FILE AND PURCHASE YOUR LICENSE FROM THE CITY FOR A \$75 CHARGE. DUE TO STATE LAWS, CATERER NEEDS 4 WEEKS' NOTICE IF YOU WOULD LIKE TO HAVE A CASH BAR AVAILABLE TO OBTAIN THE SDL FROM THE CITY GOVERNMENT NO SUBSTITUTIONS ALLOWED FOR ITEMS WITHIN A BAR PACKAGE, PLEASE

ADDITIONAL OFFERINGS

BARTENDER FEE: WE REQUIRE 1 BARTENDER PER EVERY 100 GUESTS. ADDITIONAL BARTENDERS REQUESTED OVER STANDARD NEEDED AMOUNT WILL BE CHARGED \$250.

LIQUOR LICENSE: A CATERED AFFAIR HOLDS A LIQUOR LICENSE WITH THE STATE OF NEBRASKA (NO OTHER STATES). BECAUSE OF THIS, WE MUST ABIDE BY ALL NEBRASKA LIQUOR LAWS. WE RESERVE THE RIGHT TO STOP SERVING ANY PERSON THAT APPEARS TO HAVE OVER CONSUMED ALCOHOL. WE RESERVE THE RIGHT TO STOP BAR SERVICE AT ANY EVENT, AT ANY TIME. WE WILL SHUT DOWN ANY BAR IF WE FIND ANY ALCOHOL BROUGHT IN BY GUESTS. WE RESERVE THE RIGHT TO REQUIRE ID FOR ANY PERSON APPEARING TO BE UNDER THE AGE OF 40. LIQUOR LAWS FORBID US FROM HANDLING, SERVING, OPENING, OR TRANSPORTING ANY LIQUOR, BEER, OR WINE THAT WAS NOT PURCHASED BY OUR COMPANY FROM A LICENSED LIQUOR WHOLESALER. IF YOU PURCHASE YOUR LIQUOR/WINE/BEER YOURSELF OR THROUGH ANOTHER CATERER, WE ARE ONLY ALLOWED TO BUS BAR GLASSES. LIQUOR LAWS DO NOT ALLOW US TO ASSIST IN SERVING ANY OF THE LIQUOR/BEER/WINE THAT WE DID NOT PURCHASE. LIQUOR LAWS FORBID US FROM SERVING ANYONE WHO DOES NOT HAVE THEIR VALID ID ON THEM, REGARDLESS OF THEIR AGE. VALID ID MUST BE PRESENT AT THE EVENT, OR THE BARTENDERS CANNOT SERVE THEM.

NO SHOTS POLICY OUR BARTENDERS ARE NOT ALLOWED TO SERVE ANY SHOTS TO ANY GUESTS AND IF THEY ARE CAUGHT DOING SO WILL BE TERMINATED.

NO SUBSTITUTIONS ALLOWED FOR ITEMS WITHIN A BAR PACKAGE, PLEASE SEE ADDITIONAL OFFERINGS. ALL BAR PACKAGE BRANDS LISTED MAY CHANGE SUBJECT TO AVAILABILITY, ANY SUBSTITUTION BY THE CATERER WILL BE THAT OF EQUAL VALUE.
